DPRK Will Settle Damage Incurred by Sanctions of U.S. and Its Followers

Pyongyang, October 20 (KCNA) -- A spokesperson of the Sanctions Damage Investigation Committee of the Democratic People's Republic of Korea issued the following statement on Friday:

Today, the manoeuvres of the U.S. and its followers to sanction and stifle the DPRK have reached the extremely vicious and barbarous phase in their attempt to obliterate the rights to existence and development of our State and people, destroy the modern civilization and turn the world back into a dark mediaeval age.

They turned away even the articles of the UN Security Council "resolutions" which stipulated that the sanctions should not give negative impact on the humanitarian assistances of the UN agencies which are influenced by the sanctions, although they are conducted in a more transparent way. This is the reality today.

The assistances of the UN agencies undertaken in all regions and countries of the world contribute to carrying out the noble missions of the UN aimed at securing global peace and security, developing international relations and promoting international cooperation in economic, social and cultural fields as well as other various areas.

However, the United States and its followers cut off the normal economic and trade activities of the DPRK in all-round way and resort to the unprecedented sanctions and stifling acts in their attempt to obliterate even the basic right to existence. They go even further to take issue with the assistances of the UN agencies which are conducted without any snag and impede their implementation in every way possible.

Unlike in other countries, the assistances of all the UN agencies in the DPRK including UNDP, UNICEF and UNFPA are taking place under the strict supervision of the sanctions committee of the UNSC.

As a result, the banking channel of the UN agencies is suspended, delivery of aid goods is delayed and even the ordinary daily consumer goods are restricted under the pretext of dual use, thus creating tremendous obstacles in the protection of the rights and existence of the children and women and causing damage to the people's livelihood, nothing to say of the civilian economy.

Unable to resist strong backlash within and without, they claim to have allowed the transfer service of fund for UN agencies resident in the DPRK. However, due to the absence of practical measures, the transfer service is suspended and the assistances are not progressing.

The delivery of Mobile Digital X-ray equipment and reagents for diagnosis of Tuberculosis, insecticides for Malaria vector control and Emergency Reproductive Health Kits procured and provided by the UN agencies including UNICEF and UNFPA for protection and promotion of the health of children and women have been delayed for several months under the unjustifiable pretext of various reasons in the countries of sale and transit this year. The Gene Xpert Cartridge for diagnosis of Multi-Drugs Resistant tuberculosis patients have not been delivered at all since 2017.

This is a clear act of human rights violation that denies and infringes upon the right to a standard of living adequate for health and well-being including clothing, food, housing, medical care and necessary social services stipulated in the Universal Declaration of Human Rights

Thus, it is obvious that the aim of the sanction is to overthrow the system of the DPRK by isolating and stifling it and intentionally bring about humanitarian disaster, instead of "preventing weapons development" as claimed by the U.S. and its followers.

The more unprecedentedly harshest sanctions and strongest pressure the U.S. and its followers impose on the DPRK, the higher the banners of independence, simultaneous development and self-reliance it will uphold, and thus settle the damage to the end incurred by the sanction, decisively frustrating the reckless nuclear war moves and the despicable plot of sanctions and pressure of the enemies.

KAPPC Spokesman Blasts Japanese Authorities' Reckless Action

Pyongyang, October 23 (KCNA) -- As already reported, the Japanese reactionaries recently dissolved the House of Representatives without any proper justification in a sinister attempt to prolong their remaining days, claiming it as a "momentous event" to overcome "the nation's difficulties".

Great irony is that the authorities of Japan are getting frantic with the move to paint itself as "the centripetal force for tiding over the national crisis", building up the public opinion that the crisis, caused by their poor administration, is ascribable to "nuclear threat" from the DPRK.

In this regard, a spokesman for the Korea Asia-Pacific Peace Committee issued a statement on Sunday, which said:

What the Japanese reactionaries seek in deliberately linking their step to dissolve the House of Representatives with the DPRK is to gratify their ambition for staying in power and pave the groundwork for reinvasion of the Korean peninsula in order to realize the old dream of the "Greater East Asia Co-Prosperity Sphere", taking advantage of the nuclear war moves of the U. S.

This is well proven by the fact that Japan examined a plan for giving logistic support to the U.S. troops and putting down "armed refugees" with mobilization of the "Self-Defense Forces" in contingency on the Korean peninsula, while loudly trumpeting about the U.S. military attack on the DPRK.

Japan enacted another sinister political cartoon only to reveal its ugly true colors as a war state which has pressed ahead with its militarization, making a mockery of the world for decades since its defeat.

The Japanese reactionaries are behaving frivolously far from sincerely reflecting on their most heinous crimes against the Korean people and making reparation for them.

Such an action is nothing but the last-ditch efforts of those frightened by the tremendous might of the DPRK which has neared the completion of the program of the state nuclear force.

The Japanese authorities' dreaming of being exposed to golden rain, believing in the lunatic's empire as in Heaven is as foolish a dream as barking at the moon.

Now that it is crystal clear to all that Japan is pushing ahead with the reinvasion preparations in the final stage with the backing of the U.S., the DPRK has the right to take a tough countermeasure for self-defense.

The Japanese reactionaries would be well advised not to run amuck, well aware of the strategic position of the DPRK as a nuclear power of Juche and a world power.



KCNA Commentary Terms U.S. Chieftain Bringing Nuclear Holocaust to Humankind

Pyongyang, October 18 (KCNA) -- The U.S. plans to resume nuclear tests as part of its stepped-up moves for nuclear buildup.

There is widespread opinion among the conservative hard-liners within the U.S. that nuclear test has to be resumed and old warheads have to be exploded on the basis of random selection under the pretext of "security environment more complicated than the Cold War era". Against this backdrop, the government authorities openly hint at the possibility of nuclear tests, saying the issue of whether to resume the nuclear test or not will be "discussed further."

Politico, the New York Times and other U.S. media report that the Trump administration can resume nuclear tests to extend the shelf-life of the existing nuclear weapons and to verify the performance of newly developed nuclear warheads.

The U.S. nuclear test resumption moves have become all the more serious as they were carried out on the extension of Trump's ferocious nuclear confrontation racket calling for "increasing the nuclear capabilities to greater extent until the world can get discretion of the U.S. strength".

Soon after taking office in the White House, Trump assigned the Defence Department with the task to reexamine and estimate the nuclear force, complaining that the U.S. nuclear force has been left far behind other countries, and has squandered a great amount of funds into its modernization.

The recent NBC report that Trump called for increasing nuclear weapons ten-fold at a security session in July to the shock of all the audience clearly proves to what extent the U.S. chief executive has reached in his nuclear hysteria.

The U.S. attempt at the resumption of nuclear test is becoming a reality at Trump's zealous instigation.

B61-12 tactical nuclear bomb test in Nevada a month ago is just a prelude to it.

The U.S. has conducted more than 1 000 nuclear tests and has a stockpile of the greatest number of ultra-modern nuclear weapons. Not content with this, it is planning to resume nuclear tests. This is an indication of its sinister hegemonic ambition to dominate the world with an unchallenged nuclear edge.

It is the U.S. gangster-like logic that all the countries have to be its slaves under its nuclear stick or die.

The U.S. nuclear tests will naturally lead to nuclear arms race among big powers, disrupt international NPT system and further increase the danger of a nuclear war on the earth.

Furthermore, the U.S. is the empire of evil which inflicted the nuclear holocaust on humankind for the first time in history. This fact makes the international community closely watch the nuclear criminal state which has strong proclivity to commit the crime again.

The U.S. chiefly to blame for threatening world peace and security is still holding the DPRK-targeted large-scale nuclear war drills in south Korea and in waters off it, watching for an opportunity to mount a preemptive nuclear strike. It, therefore, does not make any sense for the DPRK to abandon nuclear weapons under this situation.

The DPRK will continue to bolster the military capability for self-defence and preemptive attack with the nuclear force as a pivot as long as the U.S. and its followers' nuclear threat and blackmail continue, and this will last until all the nuclear weapons are abolished on the earth.



**Spokesman for CCNR Slams S. Korean Authorities'
"Policy towards North"**

Pyongyang, October 13 (KCNA) -- A spokesman of the Consultative Council for National Reconciliation issued a statement on Friday as regards the fact that the south Korean authorities are persisting in their fantastic "policy towards the north" despite the strong protest and denunciation by people of various circles.

The DPRK gave the south Korean authorities advice enough to understand that their "policy towards the north", keynote of which is "dialogue in parallel with the enforcement of sanctions and pressure", is utterly infeasible, contradictory and sheer sophism and little short of a copy of the anti-reunification and anti-national confrontation policy pursued by the conservative regime.

However, the south Korean authorities further bedeviled the north-south relations by more persistently clinging to the moves for putting sanctions and pressure upon the DPRK to please the U.S., the statement says, and goes on:

Their behaviors go to prove that they are only keen on keeping their face and staying in power, utterly indifferent to the demands of the candlelight demonstrators and all compatriots for the improvement of the inter-Korean relations and peace on the Korean Peninsula.

What is more ridiculous is that they are dreaming about compelling the north to come out for dialogue with sanctions and pressure.

This is nothing but revelation of their calculation that they would regard fellow countrymen as enemy.

There is a limit to our patience.

Explicitly speaking once again, pro-U.S. activities and improvement of the north-south relations and sanctions and pressure and dialogue can never go together.

The south Korean authorities should draw a lesson from their miserable position of isolation.

The conservative group is given a breathing spell and even censuring the pro-democracy and pro-reform forces at a time when the ruling forces are at a loss, pursuing their fantastic "policy towards the north." They should clearly understand that it is an unpardonable crime against the nation to make a mess of the results of the candlelight actions.

If they continue behaving imprudently, they will bring only a horrible disaster, far from improved north-south relations.

They should come to their senses, though belatedly, and make a bold decision to fundamentally change the "policy towards the north" as

demanded by the people and take to the road for the nation and independent reunification, not toeing the U.S. line. -0-

S. Korean Regime Will Face Ruin for Dreaming of "Unification through Absorption"

Pyongyang, October 14 (KCNA) -- A spokesman of the Consultative Council for National Reconciliation in a statement Saturday denounced the south Korean puppet regime for getting reckless while calling for "unification through absorption."

The Supreme Court, a puppet judicial organ, let out a litany of sleep-talking like focusing on the issue of setting up "examination committee for reappointing judicial officers in the north", "schooling" those who passed the examination and "including them in the Unified Ministry of Justice", the issue of "reinstating and reappointing law-related officials who had been subject to suppression under the north's regime", and the issue of dispatching personnel necessary for judicial organs in the north after "unification through absorption" while crying out for studying the "issue of handling" the north's judicial organs from now as they play a pivotal role in defending the social system.

The statement branded this as another intolerable politically-motivated provocation to the DPRK.

The present authorities of south Korea are talking about candlelight mindset while styling themselves a "government supported by candlelight" but in fact, they are covering the path quite contrary to it.

Those, who had pursued the ambition of "unification under the liberal democracy" while shunning the sincere reconciliation of the nation unanimously desired by all Koreans, faced the most miserable end without exception.

This being a hard fact, the present ruling quarters has not yet got awakened from illusion of "unification through absorption". Deriding its dirty and despicable acts, the statement continued:

We are consistent in our stand to settle the reunification issue in a peaceful way, but if the puppet forces dare provoke the DPRK, we will put a final end to the evil cycle of confrontation between the fellow countrymen with the powerful revolutionary armed forces which have been built up to victorious conclude the standoff with the U.S. as we had already clarified.

We will also keep tabs on those traitors to the nation including the fools who invent such issues as "handling" the law enforcement officials in the back room while dreaming a pipe dream of "unification through absorption".

The judicial organs of the DPRK will punish without discrimination by our law the vicious elements of the puppet judicial authorities running reckless as a shock brigade in executing the undemocratic laws inciting sycophancy toward the U.S. and confrontation with the fellow countrymen after enacting them while working as henchmen executing the U.S. policy for colonial domination.
